- 1. Fees for jury fee and booth space fee need to be paid with 2 separate checks written to Commonwheel Artists:
 - Jury Fee (non-refundable) \$ 35.00
 - Food Vendor Booth Fee \$385.00
 - Notification of acceptance will be sent by June 1, 2024.
- **3.** Food Vendor spaces are approximately 12' x 16'.

4. We cannot accept applications for Food Trucks.

5. It is best to have a menu that specializes in one style of food, as the jury looks for diversity and quality of food to be offered at this festival.

FOOD SERVICE ITEMS REQUIREMENTS

The acceptance form will have more details.

- No styrofoam.
- Use recyclable or compostable items.
- We will have recycling bins in the park.
- We will determine if there will be composting bins in early 2024.

REQUIRED FOOD VENDOR PAPERWORK

2. Required for a food vendor application:

• Copy of liability insurance naming as co-insured: a) The City of Manitou Springs

- b) Manitou Commonwheel Artists Association, LLC 102 Cañon Ave, Manitou Springs, CO 80829.
- Copies of licenses & fees paid that comply with all El Paso County Health Dept. requirements.
- El Paso County Public Health Special Event License.
- Copy of compliance with El Paso County Review.
- Valid CO Retail Food Establishment License.
- Failure to submit documents by July 31 will mean exclusion from the Festival.

HEALTH SAFE/COVID-19 CONSIDERATIONS

The Commonwheel Art Festival will be following all the regulations set in place relating to COVID-19 by the city and county government agencies to assure all participating food vendors, artists, our volunteers and the art patrons who come to festival are safe.

The following guidelines are suggested in 2024 by the state to be in place for food service at outdoor events.

- Food vendors must provide single-use or single serving condiments, no pumps.
- There can be no items that many people might need to touch on a table or shelf at the edge of your booth.
- Cold beverages must be stored in an ice chest that is not accessible by the public.
- Use menu boards that can easily be read at a distance from the ordering and serving areas.
- Provide contactless payment options when possible.
- Increase cleaning and disinfection protocols.
- Encourage the use of non-latex gloves or frequent hand washing. Use a fresh pair of gloves after each hand washing.
- Change gloves between tasks such as, taking orders, cooking, accepting payment, and serving food.
- Have one area where orders are placed and another for where the prepared food is handed to the customer.

SALES TAX

- The Commonwheel Artists Festival is required by the City of Manitou Springs, to have a CO Multiple Event License and collect all sales tax under that license.
- Food Vendors must collect 9.03% sales tax on all sales of all food and drink items sold at the festival.
- Food Vendors must pay to Commonwheel Artists all State, City & County sales taxes on Monday, Sept. 4, 2024, starting at 5pm at the Information Booth.
